REGIONAL CONSULTATIVE COMMITTEE

Functions of the Regional Consultative Committee

The Regional Consultative Committee (RCC) was first established following a resolution adopted by the Thirtieth Session of Regional Committee in 1983. It is composed of eight members, designated by the Regional Director, acting in their own personal capacity, that is, they do not represent their governments. The terms of reference of the RCC include advising the Regional Director on policy and strategy in the Region for the development of technical cooperation among developing countries (TCDC), preparing the programme budget, reviewing methods of work of the Regional Committee, and any other matters referred to it by the Regional Director Membership is initially for two years for half of the members, and three years for the other half. The RCC meets once a year, usually in late August/early September¹

Seventeenth meeting of the RCC

The seventeenth meeting of the Regional Consultative Committee was held in the Regional Office, Alexandria, Egypt, on 1 and 2 October 1993 The RCC reviewed the follow-up actions taken on the recommendations of its previous meeting

The topics discussed included

- the Ninth General Programme of Work Covering the Period 1996-2001,
- the usefulness of visits of senior national officials to the Regional Office,
- World Bank involvement in the field of health,
- Cost-sharing in health systems,
- Promoting the PHC approach, focusing on catchment areas of health facilities, and
- the use of traditional medicine in health care systems

In addition, the Regional Director briefed the Committee on the work of the Executive Board Working Group on the WHO Response to Global Changes, and on an important resolution (WHA46 35) of the Forty-sixth World Health Assembly, calling for budgetary reform and a simplified presentation of the Proposed Programme Budget

The RCC was impressed by the clarity of thought and style of the Ninth General Programme of Work (9th GPW), the conciseness in the presentation of concepts, and its greater flexibility and adaptability at all levels, and recommended regional inputs to the 9th GPW document for consideration by the Regional Committee

The action taken by the Regional Office to evaluate the usefulness of the visits of senior national officials to the Regional Office assessing the achievement of objectives and the costeffectiveness of such meetings was welcomed The RCC's recommendations included *ad hoc* visits to the Regional Office by newly appointed key national officials, allocation of a certain

percentage of country funds for activities involving intersectoral collaboration, organization of workshops and meetings invited to discuss appropriate means of intersectoral coordination, etc

It was recommended that WHO develop guidelines for Member States on conducting negotiations with World Bank teams during the formulation of health and other national development projects that have health implications for funding by the Bank Member States were urged to use WHO as an advisory body during negotiations concerning these projects for funding by the Bank

The importance of cost containment and cost-sharing mechanisms in the future development of health care delivery was emphasized These mechanisms should be viewed as one of the means of improving the quality of health services and should take into consideration (a) basic health care services and their accessibility to all, and (b) appropriate technology in line with the values and ethics of the regional culture

The RCC recommended the establishment of a regional body to advise on policy choices in health economics, conduct by countries, in collaboration with WHO, of cost analyses at various health care levels and development of national mechanisms to sensitize health providers, as well as the public, to the cost of health care services, promotion of bulk procurement of various medical supplies at national, sub-regional and regional levels, development of national mechanisms to coordinate the health services provided by various institutions at national level, and collaboration by Member States with WHO in developing national lists of essential equipment, basic laboratory tests, and other basic health supplies

The RCC supported innovative approaches that strengthen PHC and community development, and recommended that health workers be trained to play a leading role in community motivation and mobilization, and catchment areas, whenever considered, be clearly defined for each facility and appropriate referral systems should be developed and enforced Furthermore, a good system of keeping records should be developed to control the patient's movements, to avoid transfer between various catchment areas and by-passing of first levels of health care

The importance of use of traditional medicine in health care systems and the need for a practical approach to use benefits from the existing practices of traditional medicine to support the overall objectives of HFA was emphasized. It was recommended, *inter alia*, that efforts be made to carry out situation analyses of the status of traditional medicine in the Region and generate more quantitative data on its actual trends of utilization and WHO convene a meeting of an expert group to discuss various technical issues raised in the RCC discussions.

REGIONAL COMMITTEE FOR THE EASTERN MEDITERRANEAN

Functions of the Regional Committee

The Regional Committee (RC) for the Eastern Mediterranean is the main governing body on policy matters for the WHO Eastern Mediterranean Region It also supervises the activities of the Regional Office Its functions include

- a) to formulate policies governing matters of an exclusively regional character,
- b) to supervise the activities of the Regional Office,
- c) to suggest to the Regional Office the convening of technical conferences, and such additional work or investigation in health matters as in the opinion of the Regional Committee, would promote the objectives of the Organization within the Region,
- d) to cooperate with other WHO regional committees and with those of other United Nations specialized agencies and with other regional international organizations having interests in common with the Organization,
- e) to tender advice—through the Director-General—to the Organization on international health matters that have wider-than-regional significance,
- to recommend additional regional appropriations by the governments of countries in the Region if the proportion of the central budget of the Organization allotted is insufficient to carry out regional functions,
- g) such other functions as may be delegated to the Regional Committee by the World Health Assembly, the Executive Board or the Director-General The EMR Regional Committee consists of all Member States forming the WHO Eastern Mediterranean Region

The Regional Director is the ex-officio Secretary of the Regional Committee

The Regional Committee meets annually (first Saturday of October) either in one of the EMR Member States or in the Regional Office, in accordance with the invitation received

Fortieth Session of the RC

The Fortieth Session of the Regional Committee was held in Alexandria, Egypt, from 2 to 5 October 1993 The Regional Committee elected H E Dr Alireza Marandi (Islamic Republic of Iran) as its Chairman, and Dr Khalifa Ahmed Al-Jaber (Qatar) and Dr Walid Ammar (Lebanon) as its Vice-Chairmen For the Technical Discussions, Dr Moncef Sidhom (Tunisia) was elected Chairman

Palestine was welcomed as a member in the Regional Committee for the Eastern Mediterranean

The RC considered various topics, including the Ninth General Programme of Work Covering the Period 1996-2001, progress reports on AIDS, malaria and WHO-sponsored research activities in the Eastern Mediterranean Region the seventcenth meeting of the Regional Consultative Committee and the Joint Government/WHO Programme Review Missions in 1993 The Technical Discussions were on the subject of "the Role of Women in Support of Health for All" and the technical papers were on leishmaniasis and abuse of narcotics and psychoactive drugs

The Fortieth Session of the Regional Committee adopted 16 resolutions It also agreed on 6 decisions

The following is a list of the resolutions and decisions adopted, along with the text

PROGRAMME MATTERS

EM/RC40/R.1 Annual Report of the Regional Director

All the representatives of the Member States commended the Regional Director on his Report for 1992 on the Work of WHO in the Eastern Mediterranean Region and sought WHO's assistance and advice on various proposals. The resolution urges Member States that are economically more secure to donate the whole or a part of their country allocations to support those Member States of the Region that have greater need.

EM/RC40/R.3 Regional Strategy for Health and Environment

The Regional Committee adopted the draft strategy drawn up at an intercountry consultation in Amman in June 1993

EM/RC40/R.4 Report of the Executive Board Working Group on the WHO Response to Global Change

The Regional Director explained in detail the report and the recommendations of the Executive Board Working Group WHO Response to Global Change The Director-General said that the activities for the implementation of the recommendations were to be grouped together since they had common purposes, namely the rationalization of the work of governing bodies and their subcommittees or improvement in certain managerial aspects of WHO's work. He provided a time-frame for fulfilling the recommendations, noting that a number had already been met Regarding the procedure for selecting the Regional Director, the Regional Committee decided, after considerable discussion, to continue with the existing practice, and to seek the views of the Regional Consultative Committee on the report

EM/RC40/R 5 The Role of Women in Support of Health For All

All those who participated in the discussions were in complete agreement that further training of women was essential in order to enhance their potential role in support for Health for All in the family, community and the society at large

EM/RC40/R.6 Acquired Immunodeficiency Syndrome (AIDS) - Progress Report

The delegates who took part in the discussions on this topic expressed their concern at the possibility of AIDS becoming a serious threat at a later date, although it was not one at present. They agreed that the number of AIDS cases and HIV infections currently reported may not truly reflect the actual situation, and cautioned against any complacency. In countries that face security and refugee problems, there were no data concerning the magnitude of the disease and infection. The Committee therefore urged Member States to collect reliable data and, in the absence of any drugs or vaccines, to continue to provide effective education and information about the infection.

and the disease and to develop integrated control programmes for AIDS and other sexually transmitted diseases

EM/RC40/R.7 Leishmaniasis

The present status of leishmaniasis was described. The use of insecticide-impregnated bednets was a preferred approach to achieving control of the disease. While zoonotic foci were difficult to control, anthroponotic foci could be brought under control. The possibilities of integrating malaria and leishmaniasis control programmes deserved close examination, since the control of leishmaniasis has frequently been a side-effect of malaria control activities.

EM/RC40/R.8 Poliomyelitis Eradication in the Eastern Mediterranean Region

The Committee reiterated its goal of eradication of poliomyclitis from the Region by the year 2000 and called upon Member States to take appropriate steps necessary to ensure attaining the goal, including self-sufficiency in vaccine production, surveillance of acute flaced paralysis, and ensuring availability of resources for strengthening of national laboratories for diagnosis

EM/RC40/R 9 Abuse of Narcotics and Psychoactive Drugs

The technical paper provided basic information on the subject and suggested a strategy to combat drug abuse based on identified resources. It also contained information about international organizations engaged in dealing with the problem.

There was consensus that abuse of narcotics and psychoactive drugs was becoming a menace in the Region, and that all efforts should be make to tackle the problem

EM/RC40/R.10 Malaria Control

Concern was expressed at the current malaria situation particularly in those countries where no nationwide control programmes exist. Instability, insecurity, movement of populations, lack of resources, high prices of insecticides, development of resistance by vectors and parasites, all contributed to the present situation. Use of mechanical and biological control methods is preferred to chemical methods

EM/RC40/R 11 Report on the Progress of WHO-sponsored Research Activities in the EMR

The Regional Committee felt that health systems research required further expansion in all countries. There should be closer cooperation between ministries and universities. National coordinating bodies for research should be established, and strengthened where they already exist

EM/RC40/R 14 Report of the Regional Consultative Committee (Seventeenth Meeting)

The Regional Committee endorsed the report of the Regional Consultative Committee and requested Member States to implement its recommendations. One of the recommendations was for *ad hoc* visits to the Regional Office by newly appointed key national officials (See also the earlier section of this briefing.)

EM/RC40/R 15 Ninth General Programme of Work Covering the Period 1996-2001

The Regional Consultative Committee reviewed the Ninth General Programme of Work (9th GPW) at its seventeenth meeting in September 1993 and was impressed by the clarity of thought and style of the Programme, the conciseness in the presentation of concepts, and its greater flexibility. The representatives found the 9th GPW clear and concise, and suggested that the Executive Board be requested to include more information on resource mobilization.

EM/RC40/R.2 Membership of Palestine in the Regional Committee

Following a statement by the Director-General of WHO of the consultations held with Israel on the subject, Palestine was invited as a member in the Regional Committee under Article 47 of the WHO Constitution

EM/RC40/R 13 Health Conditions of the Arab Population in the Occupied Arab Territories, Including Palestine

EM/RC40/R.12 Report of the Ministerial Committee on Methods of Raising Extrabudgetary Funds for the Promotion of Health Initiatives in the Eastern Mediterranean Region.

The creation of an association was proposed by the Ministerial Committee pursuant to EM/RC39/R 1 to mobilize funds from private and other sources in the support of health development in the Region, including Member States and EMRO This would be independent from WHO

EM/RC40/R.16 Place and Date of the Forty-first Session of the Regional Committee, 1994

The Regional Committee decided to hold its Forty-first Session in Alexandria, in case no other invitation is received, from 1 to 4 October 1994, in consultation with the Chairman of the Committee

The Regional Committee,

Having reviewed the Regional Director's progress report² on acquired immunodeficiency syndrome,

Considering the increasing spread of HIV infection in the Region, Recognizing the need to intensify efforts to prevent the further spread of AIDS,

- 1 THANKS the Regional Director for his report and for the efforts made in implementing the earlier resolutions of the Regional Committee on AIDS,
- 2 URGES Member States
 - 2 1 to ensure a high level of national commitment to AIDS prevention and control and to provide adequate human and financial resources to implement national AIDS programmes,
 - 2.2 to enlist the active involvement of all national sectors, as well as nongovernmental bodies, concerned in the fight against AIDS,
 - 2.3 to collect reliable data on HIV infection and AIDS, and to submit regular reports to WHO,
 - 2.4 to continue to provide effective education and information about HIV infection and AIDS to the general public, as well as to those at increased risk of infection,
 - 2.5 to continue to provide adequate care to persons with HIV infection and AIDS, respecting their human rights and dignity, and avoiding any stigmatization or discrimination,
 - 2.6 to develop an integrated control programme for AIDS and the other sexually transmitted diseases,
 - 27 to continue to ensure the safety of blood, blood products and tissue or organ donations,
- 3 REQUESTS the Regional Director
 - 3 1 to continue to ensure the provision of the necessary support to Member States in their national AIDS control programmes,
 - 3 2 to inform the Regional Committee regularly about the regional and global AIDS situation, as well as about the progress in the implementation of AIDS control programmes,
 - 3 3 to enhance cooperation and coordination among the Member States in their efforts to prevent and control AIDS

EM/RC40/R 7 Leishmaniasis

The Regional Committee,

Having reviewed the Regional Director's report' on "Leishmaniasis",

Commending the initiatives and activities undertaken by the Regional Office and some Member States in controlling the disease,

Commending also the initiative taken by the Regional Director to promote and support research on the epidemiology and control of leishmaniasis,

- 1 URGES Member States concerned
 - 11 to undertake epidemiological assessment of leishmaniasis in their countries,
 - 1 2 to prepare national programmes for the prevention and control of leishmaniasis, using a multisectoral approach that involves all national authorities concerned,
 - 1 3 to encourage and promote community involvement in preventive and control activities, particularly at the foci of leishmaniasis,

- 1 4 to ensure continued availability of diagnostic facilities and drugs in areas where leishmaniasis is endemic, and support the introduction of control measures against vectors and reservoir hosts,

- 2 REQUESTS the Regional Director
 - 2.1 to continue to support Member States in the planning and implementation of national programmes for the control of leishmaniasis,
 - 2.2 to facilitate and support intercountry cooperation on the control of the disease

EM/RC40/R.8 Poliomyelitis Eradication in the Eastern Mediterranean Region

The Regional Committee,

Having reviewed the Regional Director's progress report' on "Poliomyelitis Eradication in the Eastern Mediterranean Region",

Appreciating the progress being made towards the goal of poliomyelitis eradication in the Region,

Noting with satisfaction that all Member States have set national targets for the eradication of poliomyelitis by the year 2000,

Being fully aware that the goal of the eradication of poliomyelitis from the Region will not be achieved unless there is a continuing acceleration of national immunization programmes,

- 1 COMMENDS the Regional Director for the efforts made to achieve the regional goal of poliomyelitis eradication,
- 2 ACKNOWLEDGES the Regional Director's initiative towards achieving regional selfsufficiency in production and quality control of vaccine,
- 3 URGES Member States
 - 3 1 to reaffirm their commitment to eradicating poliomyelitis and to make available the staff and resources necessary to implement their national plans,
 - 3 2 to ensure the availability of sufficient quantities of OPV that meets WHO's quality standard for both routine and supplementary immunization,
 - 3 3 to give high priority to the surveillance of acute flaccid paralysis as well as the other EPI diseases,
 - 3 4 to promote effective participation of the different medical sectors and the community in all the activities of the programme,
 - 3 5 to ensure the availability of the necessary resources for strengthening national laboratories for the diagnosis of poliomyelitis,
- 4 REQUESTS the Regional Director
 - 4 1 to continue his efforts to achieve regional self-sufficiency in vaccine production and quality control, and to support countries in obtaining sufficient quantities of OPV,

- 4 2 to coordinate with other organizations of the United Nations system, intergovernmental agencies and governmental and non- governmental organizations to mobilize sufficient funds to meet all requirements for the eradication of poliomyelitis, in particular, for vaccine supply,
- 4.3 to continue to monitor progress by various means,
- 44 to keep the Regional Committee regularly informed about progress towards eradication of poliomyelitis from the Region

EM/RC40/R.9 Abuse of Narcotics and Psychoactive Drugs

The Regional Committee,

Having reviewed the Regional Director's report¹ on "Abuse of Narcotics and Psychoactive Drugs",

Considering the magnitude of the problem and recognizing that continued efforts are required for the prevention and control of this grave health, social and economic problem in the Region,

1 URGES Member States

- 1 1 to provide the necessary commitment and support to a comprehensive, multisectoral programme for the prevention and control of drug abuse, using religious, cultural, educational and other resources for promoting healthy life-styles,
- 1 2 to establish reliable, up-to-date systems for collecting information about drugs, and to support upgrading of existing systems,
- 1.3 to share among themselves and with WHO information, technical expertise and experience on different aspects of drug abuse, treatment and rehabilitation,
- 2 URGES the Regional Director
 - 2.1 to provide to Member States the necessary technical support to develop regular datacollection mechanisms, thereby facilitating exchange of information and experience among themselves and between them and WHO,
 - 2.2 to strengthen existing reference centres and to support the establishment of new centres in countries where drug abuse is a severe problem

EM/RC40/R.10 Malaria Control

The Regional Committee,

Having reviewed the Regional Director's progress report² on malaria control in the Region, Being concerned by the progressive increase in cases of malaria in most of the countries in which it is endemic and the increasing malaria threat to the Region,

Recognizing the need to intensify efforts to control malaria,

1 REITERATES its earlier resolution, EM/RC37/R 11, the recommendations of which remain valid and should be pursued,

 - 21 to support fully the four technical elements of the Global Malaria Strategy, namely

Noting that marked progress in research for health has taken place in only a few countries of the Region,

Having noted the presentation made by the Regional Director on the recommendations of the ad hoc committee established by the Thirty-ninth Session of the Regional Committee pursuant to resolution EM/RC39/R 1,

Being desirous of making every effort to raise the greatest possible amount of extrabudgetary funds for the health development projects in the Region,

- 1 WELCOMES the recommendations of the *ad hoc* committee on methods of raising extrabudgetary funds for supporting health development projects sponsored by the Regional Office, especially the establishment of a regional body for health development, and
- 2 CALLS UPON the Regional Director to continue his efforts to raise extrabudgetary funds and to cooperate with any initiative aimed at supporting health development in the Region, including collaboration with the regional body for health development when established

EWRC40/R.13 Health Conditions of the Arab Population in the Occupied Arab Territories, Including Palestine

The Regional Committee,

Mindful of the basic principle established in the WHO Constitution, which affirms that the health of all peoples is fundamental to the attainment of peace and security,

Expressing the hope that peace talks among the parties concerned in the Middle East will lead to a just and comprehensive peace based on the principles of international legitimacy and, in particular, on the United Nations Security Council resolutions 242 and 338,

Taking note of the developments of the peace process in which the parties concerned in the Middle East are involved, and the imminent transfer of authority to the Palestinian people, including the transfer of the authority for health, which entails untiring efforts on the part of the Palestinian people to reconstruct and rehabilitate the health infrastructure which deteriorated during occupation,

Stressing the urgent need to mobilize an effective international effort to achieve that reconstruction and rehabilitation, and the importance of the role of the World Health Organization in this respect,

Recognizing the need to provide further health support and assistance to the population of the occupied Arab territories, and to promote cooperation with them,

Appreciating the positive role already played by the Organization in providing health assistance to the Palestinian people,

Thanking the Director-General and the Regional Director for their past efforts,

- 1 REQUESTS the Director-General and the Regional Director
 - 1 1 to provide the technical support needed to facilitate the transfer of the authority for health to the Palestinian people in the following areas
 - (1) identification of basic health issues facing the Palestinian health authority,

- (2) restructuring and development of the health system,
- (3) support for a comprehensive health survey of the Palestinian people,
- (4) development of health legislation,
- (5) support for programmes to train health personnel,
- 1.2 to form a joint Palestine/WHO working group to develop the mechanisms needed for the implementation of the Palestinian national health plan,
- 1.3 to support the organization of special workshops on primary health care, and to assist in financing them to enable Palestine to take an active part in implementing the health-for-all strategy,
- 1.4 to take action and make the contacts necessary for obtaining the funds needed to meet the emergency health needs of the Palestinian people, and
- 2 CALLS upon all Member States, the organizations of the United Nations system, as well as intergovernmental and non-governmental organizations, to provide all necessary financial support and cooperation
