## 1. Composition of the Joint Coordinating Board of the Special Programme for Research and Training in Tropical Disease

The Joint Coordinating Board of the UNICEF/UNDP/World Bank/WHO Special Programme for Research and Training in Tropical Diseases (TDR) consists of 34 members drawn from among the cooperating parties as follows:

- Twelve government representatives selected by contributors to the resources of the Special Programme;
- Twelve government representatives selected by WHO regional committees from among those countries directly affected by the diseases dealt with by the Special Programme, or from among those providing technical or scientific support to the Special Programme;
- Six members designated by the Joint Coordinating Board itself from among the remaining cooperating parties;
- The four agencies that comprise the Standing Committee (UNICEF, UNDP, World Bank and WHO).

Members of the Joint Coordinating Board serve for a period of three years and may be reappointed.

From the Eastern Mediterranean Region, Bahrain, Djibouti and Islamic Republic of Iran are currently Joint Coordinating Board members. The term of office of Bahrain and Islamic Republic of Iran will expire on 31 December 2006 and they were informed of the mechanisms for re-selection to JCB membership from 2007.

The Regional Office has invited the Member States to apply for four vacancies that exist under paragraph 2.2.3 of the Memorandum of Understanding (members selected by the Joint Coordinating Board itself). From the Eastern Mediterranean Region, the Islamic Republic of Iran was selected during the Twenty-ninth Session of the Joint Coordinating Board which was held in Accra, Ghana from 19 to 21 June 2006.

#### 2. Observer status on the Joint Coordinating Board

Other cooperating parties may, on request, be represented as observers, upon approval by the joint Coordinating Board. The Eastern Mediterranean Region Member States who have observer status are: Egypt, Iraq, Jordan, Kuwait, Libyan Arab Jamahiriya, Morocco, Pakistan, Saudi Arabia, Sudan, Syrian Arab Republic, Tunisia and Republic of Yemen.

## 3. Member States selected by the Regional Committee for the Eastern Mediterranean to the Joint Coordinating Board

The following Member States were previously selected by the Eastern Mediterranean to the Joint Coordinating Board:

Egypt	1992 - 1994 (3 years)

Tunisia	1995 - 1997 (3 years)
Islamic Republic of Iran	1996 - 1998 (3 years)
United Arab Emirates	1998 – 2000 (3 years)
Oman	1999 - 2001 (3 years)

As of 1 January 2007, there will be one vacancy from the Eastern Mediterranean Region to replace Bahrain, whose term of office will end on 31 December 2006. This vacancy exists under paragraph 2.2.2 of the Memorandum of Understanding (Members selected by the WHO regional committees). In this connection, eligible Eastern Mediterranean Region countries were invited to apply for this vacancy. The following countries applied:

- Egypt
- Iraq
- Islamic Republic of Iran
- Oman
- Syrian Arab Republic

The Regional Committee is requested to nominate one Member State to serve on the JCB for a three-year period, 1 January 2007 to 31 December 2009.
