

Fifty-ninth session of the Regional Committee for the Eastern Mediterranean

### Noncommunicable diseases, maternal and child health and coronavirus in the opening session of the Regional Committee









With a heavy agenda full of important health issues, and the features of a new health strategy in the Region, the 59th session of the WHO Regional Committee for the Eastern Mediterranean opened today, Monday 1 October 2012, at the Regional Office for the Eastern Mediterranean, Cairo, with the attendance of their Excellencies Ministers of Health and Dr Margaret Chan, WHO Director-General.

Dr Ala Alwan, WHO Regional Director for the Eastern Mediterranean, in his opening address stated that the current challenges in the Region are alarming and outlined his strategy for the coming five years. He noted that the tremendous movement for change in the Region the root causes of which lie in social inequity

Dr Chan referred to the existence of huge health problems in the Region, threaten both health and economies. Diabetes care, for example, consumes 15% of the overall health budget in some countries of the Region, while out-of-pocket expenditure accounts for 75% of the national health budget in the low-income countries and hurts the poor.



#### Chair 58th session handed over to elected chair

The session was headed by Dr Ahmed Bin Mohamed Al-Saidi, Oman Minister Of Health, and chair of the 58th Session of the Regional Committee. Dr Al-Saidi, in his opening remarks said that the tremendous changes in the Region showed that there is a great difference in the level of response to threats. While some

strong points were noted, many weak points need to be strengthened.

During the rest of the first day's sessions, WHO reform and the Annual Report of the Regional Director were discussed.



### **Syria**

Dr Alwan referred to the situation in the Syrian Arab Republic stressing that it is of acute concern as access to essential health care for hundreds of thousands of displaced people represents the difference between life and death. Dr Alwan said that more than 160 primary health care clinics are damaged, of which over 40% are out of service. Two thirds of 88 hospitals are damaged, while war has prevented WHO from taking the necessary relief measures.



#### Corona virus


The novel coronavirus imposed itself on the opening speeches during the opening session. The Director-General and Regional Director confirmed that there is no evidence to date that the virus can

Following the recommendations of the Dr A.T. Shousha Foundation Committee at the Fifty eighth Session of the Regional Committee, the Executive Board awarded the Dr A.T. Shousha Foundation Prize for 2012 to Dr Shaikha Salim Al Arrayed (Bahrain) for her significant contribution to public health in the geographical area in which Dr Shousha served the World Health Organization.

Dr Al Arrayed is being honoured for her significant contribution to public health in Bahrain, in particular the control of genetic diseases.
