## 2. Report of meetings Monday, 14 October 2019

#### Chair: Dr Rana Hajjeh Director, Programme Management, Regional Office for the Eastern Mediterranean

The Regional Director, Dr Ahmed Al-Mandhari, noted that the aim of the meetings was to discuss issues of current interest and concern, to update Member States on the situation and progress in addressing those issues and to present any proposed strategic actions. The outcome of the meetings would be presented to the Regional Committee for endorsement of any recommendations. Technical meetings were held on: Pharmaceutical financing in the Eastern Mediterranean Region; Achieving the goals of the Eastern Mediterranean vaccine action plan – priority actions for acceleration; Eastern Mediterranean Region Professional Diploma in Family Medicine; Water, sanitation and hygiene in health care facilities; and the Strategic framework for the prevention and control of emerging and epidemic-prone infectious diseases.

In addition, the sixth meeting of the Programme Subcommittee for the WHO Regional Committee for the Eastern Mediterranean was held.
