

Report of the first meeting of the Programme Subcommittee of the Regional Committee

Introduction

1. The Programme Subcommittee of the Regional Committee for the Eastern Mediterranean held its first meeting on 5–6 April 2017 at the WHO Regional Office for the Eastern Mediterranean in Cairo, Egypt. The Programme Subcommittee was established by the 63rd session of the Regional Committee for the Eastern Mediterranean in resolution EM/RC63/R.6 (2016).

2. The meeting was attended by experts nominated by Member States to serve as members of the Programme Subcommittee for a duration of two years, and by WHO staff. The agenda and list of participants are included as Annexes 1 and 2, respectively.

3. The Programme Subcommittee elected the following officers to serve for a one-year term.

WHO's work in the Eastern Mediterranean Region 2017-2021

4. An outline of the Regional Director's roadmap for WHO's work in the Region during the coming five years was presented. The participants discussed the identified priorities and the way forward in finalizing the roadmap over the coming six months, emphasizing the importance of ensuring that national priorities are taken into consideration.

Preliminary outline of the 64th session of the Regional Committee for the Eastern Mediterranean

5. An outline of the agenda of the 64th session of the Regional Committee was presented to the Programme Subcommittee. A list of the proposed topics for the different agenda items was shared with participants, as well as brief proposals for each topic. The Subcommittee members listened to concise presentations for the proposals. This was followed by a detailed discussion with the secretariat and clarification sought from the responsible officers.

6. The proposals fell under four broad areas: a) progress reports under the Regional Director's Annual Report (no discussion is required on these, as they are mandated for reporting through a previous Regional Committee resolution); b) RC technical papers; c) pre-RC technical sessions; and d) panel discussion and side events.

7. After careful consideration, members of the Programme Subcommittee agreed on topics under each of the broad areas. The topics agreed are listed in Annex 3.

Next steps

8. The members of the Programme Subcommittee requested the Secretariat to draft terms of reference for the Chair and other officers, for review and consideration during the next meeting of the Subcommittee.

9. On the issue of membership, it was proposed to invite five countries (one from Group 1 and two from each of Groups 2 and 3^1) to nominate members to the Programme Subcommittee for 2019–2020. These future members would be invited to attend the meeting in April 2018 as observers, in addition to the 8 existing members. This will help to ensure continuity and smooth rotation of membership the following year.

10. The Programme Subcommittee agreed to hold its second meeting in Islamabad, Pakistan on 8 October 2017, prior to the 64th session of the Regional Committee. Additional meetings may be arranged in due course if needed.

Closing of the session

11. After thanking members of the Programme Subcommittee for their attention and valuable feedback and the Regional Office for its support, the Chair closed the session.
