By end of 2023, a systematic approach would be expected to support some countries of the Regio to adopt a portfolio of planned digital health services within their action plan. Such implementation would require technical and financial support, engaging appropriate stakeholders and partners. Meanwhile, efforts are still required to facilitate the engagement of national stakeholders to initiate national dialogue for developing an action plan in many countries in the Region. More capacitybuilding events are needed and three-level coordination efforts are required to learn from lessons in pilot countries.
