Membership of WHO governing bodies and committees

Executive Board members from the Eastern Mediterranean Region

1. The Executive Board of the World Health Organization (WHO) is composed of 34 individuals, each one designated by a Member State which is elected to do so by the World Health Assembly. In accordance with established and agreed practice, the Eastern Mediterranean Region designates five Member States to serve on the Executive Board. Each designated individual serves on the Board for a period of three years.

2. Through resolution EM/RC63/R.6, Member States agreed to group countries of the Region into three subregional groups to ensure that countries in each subregion are represented at the Executive Board at all times. This approach allocates two seats to each of the larger subregional groups (2 and 3), while the smaller group (1) is allocated one seat, as shown in Annex 1.

3. The Member States currently representing the Eastern Mediterranean Region as Executive Board members are Afghanistan, Morocco, Oman, Syrian Arab Republic and Yemen.

4. Based on regional practice and previous designations, Oman will complete its term as Executive Board member in May 2023. Qatar will be the incoming member and its term will continue until May 2026.

5. Member States are reminded that, in accordance with Article 24 of the WHO Constitution and as reaffirmed by the Health Assembly in resolution WHA51.26, individuals designated to serve on the Executive Board must be technically qualified in the field of health. Consideration should be given to individuals with a broad mix of skills and practical experience in public health and national public administration at a senior position close to the political decision-making level. Candidates for the Board should also demonstrate the ability to collaborate, coordinate and communicate within their country, between countries of the Region and with international partners.

6. The schedule of membership of Member States of the Eastern Mediterranean Region to the Executive Board is shown in Annex 2.

7. The regional distribution of elective posts for the 153rd session of the Executive Board in May 2023 is as follows: Chair – Eastern Mediterranean Region; Vice-Chairs – African Region, Region of the Americas, South-East Asia Region, Western Pacific Region; Rapporteur – European Region.

8. According to the list of previous Chairs of the Executive Board from the Eastern Mediterranean Region, the eligible member for the office of Chair would be Qatar as it has not occupied the position in the past.

9. For the Programme, Budget and Administration Committee (PBAC) of the Executive Board, each region will need to nominate at least one new member to replace members who have already served two years on the PBAC and/or will be ending their term as Executive Board member in May 2023 with the closure of the Health Assembly.

10. Qatar would be eligible to be nominated as a PBAC member as from May 2023, together with Morocco which will be completing the first year of its two-year membership of the PBAC.

Nominations from the Eastern Mediterranean Region for elected officials of the World Health Assembly

11. The elected officials of the World Health Assembly are composed of the President and the Vice-Presidents of the Health Assembly, the Chairs, Vice-Chairs and Rapporteurs of Committees A and B, and the members of the Committee on Credentials and the General Committee.

12. The Presidency and other elected offices of the Health Assembly rotate among the WHO regions every year. In May 2022, His Excellency the Minister of Health of Djibouti was elected as the President of the World Health Assembly.

13. Annex 3 shows the number of times each Member State of the Region has served as President of the World Health Assembly and as other elected officials.

14. According to the table in Annex 3, Saudi Arabia would be eligible to occupy the position of the Vice-President of the World Health Assembly, Bahrain as Chair of Committee A, Sudan as a member of the General Committee, and Djibouti of the Committee on Credentials.

Programme Subcommittee membership

15. According to resolution EM/RC63/R.6, and as part of the harmonization process and alignment of methods of work of the regional committees across the Organization, the Programme Subcommittee of the Regional Committee for the Eastern Mediterranean was established in 2016 in accordance with Rule 16 of the Rules of Procedure of the Regional Committee.

16. The Programme Subcommittee conducts its business under the following terms of reference:

- Support the preparatory work of the Regional Committee by reviewing the agenda, the working documents, reports, and draft resolutions along with its financial implications submitted by the Regional Director.
- Monitor the implementation of the recommendations and decisions of the Regional Committee.
- Recommend to the Committee additional resources required by the Regional Office and propose a mechanism for Member States to contribute additional funding for the implementation of Committee's resolutions and decisions.
- Examine the reports on the implementation of the recommendation of internal and external auditors and advise the Committee on any remedial action needed.
- Consider any other programmatic, administrative, budgetary or financial matters that the Committee, including at the proposal of the Regional Director, refer to the Subcommittee.
- Submit report on its deliberations to the Committee.

17. The Programme Subcommittee would consist of eight members, three each from among Group 2 and Group 3 countries and territories, and two from among Group 1 countries. Group 1 comprises Egypt, Libya, Morocco, Tunisia; Group 2 comprises Bahrain, Iraq, Kuwait, Oman, Palestine, Qatar, Saudi Arabia, United Arab Emirates, Yemen; and Group 3 comprises Afghanistan, Djibouti, Islamic Republic of Iran, Jordan, Lebanon, Pakistan, Somalia, Sudan, Syrian Arab Republic.

18. Members of the Programme Subcommittee are appointed by the Regional Committee and serve for a period of two years. In order to maintain some institutional memory within the Subcommittee, it is proposed to replace four of the eight members each year, following the English alphabetical order in each group. Annex 4 indicates the projected membership in 2023.

19. According to membership grouping, as of January 2022 current members are Djibouti, Egypt, Libya, Palestine, Sudan, Syrian Arab Republic, United Arab Emirates and Yemen. Egypt, Sudan, United Arab Emirates and Yemen will be outgoing on 31 December 2022, and will be replaced by Bahrain, Iraq, Islamic Republic of Iran and Morocco.

Standing Committee on Health Emergency Prevention, Preparedness and Response


20. At its May 2022 session, the WHO Executive Board agreed to establish a Standing Committee on Health Emergency Prevention, Preparedness and Response, hereafter named "the Standing Committee" (Decision EB151(2)).

21. In accordance with the approved terms of reference, the Standing Committee shall be composed of 14 members: two from each region in addition to the Chair and Vice-Chair of the Executive Board. More information about the terms of reference of the Standing Committee are available in Decision EB151(2).

22. The WHO Director-General sent a letter to the members of the Executive Board soliciting nominations from the Eastern Mediterranean Region for members to serve on the Standing Committee for its first round of two years. The deadline of 22 July 2022 was provided.

23. Submitted nominations will be discussed during the 69th session of the Regional Committee for the Eastern Mediterranean, taking place in October 2022. The approved nominations of two members will be shared with the Director-General, who will transmit them to the members of the Executive Board for consideration under a written silence procedure.
