2. Report of meetings Monday, 10 October 2022

Pre-Regional Committee technical meetings

The Regional Director, Dr Ahmed Al-Mandhari, noted that the aim of the meetings was to discuss issues of current interest and concern, to update Member States on the situation and progress in addressing those issues and to present any proposed strategic actions. Technical meetings were held on: Local vaccine production – a priority for the Eastern Mediterranean Region; Regional cervical cancer elimination strategy; The regional approach to the Decade of Action for Road Safety 2021–2030; Improving the monitoring of response to public health events and emergencies in the Region; and Strengthening hospital information systems in the Eastern Mediterranean Region. In addition, a launch event was held for a special issue of BMJ Global Health on Peace and Health.

Formal opening of the session

The opening ceremony of the 69th session of the Regional Committee for the Eastern Mediterranean was held in the WHO Regional Office for the Eastern Mediterranean, Cairo, Egypt, on 10 October 2022.

Address by the Vice-Chair of the 68th session

The session was opened by the Vice-Chair of the 68th session, H.E. Dr Ahmed Robleh Abdilleh, Minister of Health of Djibouti. Dr Abdilleh welcomed colleagues attending in person and joining virtually. He discussed the enormous impact of the COVID-19 pandemic, which had exposed weaknesses and vulnerabilities in health systems and seriously set back the provision of essential health services worldwide. It was critical to build strong, resilient and flexible health care systems capable of adapting and responding to sudden changes and events, including through strengthening health emergency surveillance and response capabilities. This would require improved preparedness and effective coordination between countries, greater digitalization of health and the adoption of the One Health approach. Dr Abdilleh thanked the WHO Regional Director and Director-General for their support, leadership and commitment.

Address by Dr Ahmed Al-Mandhari

Dr Ahmed Salim Al-Mandhari, WHO Regional Director for the Eastern Mediterranean, greeted participants. He highlighted the huge challenges faced by people in the Region, but emphasized his conviction that those challenges could be overcome. Dr Al-Mandhari introduced the theme of the Regional Committee – "Together for a healthier and sustainable tomorrow" – and the main agenda topics. These included One Health, digital health, universal health coverage and health security, holistic and integrated responses to communicable diseases, and promoting health and well-being.

Dr Al-Mandhari drew attention to the sacrifices made by colleagues working on the frontline. The Region continued to lose dedicated health workers to COVID-19 while, unacceptably, health workers and facilities had also been deliberately targeted during conflicts. WHO was launching the Imtinan Fund, an endowment to support the families of health workers lost in the line of duty.

Dr Al-Mandhari highlighted the critical need for multisectoral action. Nowhere was this more apparent than in efforts to protect the right to a clean, healthy and sustainable environment. The upcoming COP27 event in Egypt would provide an essential focus for collective action on climate change, including building health systems responsive to ever-increasing climate risks. Health systems and services must also be properly resourced and there was now a pressing need to find innovative solutions and sources of revenue for health. More than ever, the world needed a strong and sustainably funded WHO with the resources to carry out its mandate, and the Organization also needed to transform its ways of working to meet the demands placed on it.

Address by Dr Tedros Adhanom Ghebreyesus

Dr Tedros Adhanom Ghebreyesus, WHO Director-General, said that while the Region was reporting almost its lowest number of COVID-19 cases since the pandemic had begun many obstacles remained. including inequity between countries and low levels of vaccination among health workers and older people, which put the entire Region at risk. By mid-2022, it had been WHO's global target to achieve 70% coverage in all countries. Momentum needed to be maintained to build stronger architecture for health emergencies and Member States were urged to more actively engage in negotiations on a new, legally binding international instrument on pandemic prevention, preparedness and response and invest in the World's Bank's new Financial Intermediary Fund for Pandemic Prevention, Preparedness and Response to support catalytic and gap-filling financing to implement the core capacities of the International Health Regulations. The wide range of challenges facing the Region included floods in Pakistan, polio, conflict, drought, and food insecurity, exacerbated by increasing prices for food and fuel as a result of the Russian Federation's war in Ukraine. Countries needed to work to address the climate crisis, fuelled by the consumption of fossil fuels, that was making weather-related disasters more frequent and more extreme, and the upcoming COP27 meeting in Egypt represented an important opportunity to make concrete commitments to safeguard the health of the planet. The five priorities to promote, provide, protect, power and perform for health to recover from the setbacks of the pandemic and drive progress towards the "triple billion" targets and the Sustainable Development Goals were highlighted. The Director-General thanked Member States for the historic commitment they had made at this year's World Health Assembly to gradually increase assessed contributions and he reiterated WHO's commitment to continuing to support countries and making the Organization even more effective and efficient.

Address by H.E. Dr Ali M. Fakhro

The Regional Committee was addressed by three keynote speakers. H.E. Dr Ali M Fakhro, former Minister of Health and Ambassador of Bahrain, discussed major transformations shaping the world that would have profound impacts on health: the impact of neoliberalism, which he argued had led to the privatization of health and social services and aided the spread of epidemics and environmental disasters; the social media-fuelled rise in unscientific approaches to health that threatened to marginalize science-based medicine; and the growing replacement of health workers by robots and Al systems. Other challenges included environmental changes, genetic manipulation and the weaponization of bacteria and viruses. Health leaders were urged to assume new responsibilities and duties to help protect humanity and the planet.

Address by Dr Mahmoud Mohieldin

Dr Mahmoud Mohieldin provided an overview of the linkages that exist between climate change and health. The COVID-19 pandemic had exposed the real state of health systems, but this was just one example of a world at risk from pandemics, climate change, poverty, conflicts and financial crises which together now threatened to undo decades of health and development gains. Climate change was now recognized as a major health risk, both as a significant cause of death in itself and because it increased susceptibility to other causes of death. On the other hand, the health sector was a major contributor to greenhouse gases and other emissions. A process of change was needed. The health sector must not only deal with the effects of climate change but also reflect on its own part in driving it. The need to better integrate the environmental and climate dimensions into health and vice versa was now critical, and it was intended that the upcoming COP27 in Egypt would provide a focus for new approaches.

Address by Professor Ilona Kickbusch,

Dr Ilona Kickbusch presented an overview of the work of the WHO Council on the Economics of Health for All, a recent initiative that aims to foster a new approach to shape the economy with the objective of building healthier societies. Dr Kickbusch argued that health expenditure should be seen as a long-term investment, not a short-term cost; but at the same time, simply spending more money was not enough and a better understanding of economics and health was now needed to inform effective investment. The critical role of communities, households and individuals, especially women, in providing support should be recognized and embraced. Dr Kickbusch encouraged health leaders to use the policy briefs, frameworks and other guidance products developed by the Council and to contribute to the paradigm shift that was needed.
